#### Member Updates

Chandler Corriveau – Bangor Fire has recently completed haz mat operations refresher training. They are also looking at funding alternatives for a generator at the Park and Rec building. This may provide additional shelter capabilities.

Ralph Cammack – Brewer Fire is also looking for funding alternatives for a large generator that could be used at their Brewer shelter.

Eric MacDonald – That Air National Guard just completed joint exercise training with the 11<sup>th</sup> CST and the Bangor PD EOD team. They also have received a portable water trailer capable of carrying 3000 gallons of potable water.

Greg Urban – The Maine Veterans' Home in Bangor is currently in the process of updating their Emergency Operations Plan.

Oscar Gerry – Pan Am discussed and demonstrated an app for responders and civilians to locate railroad crossings in their community.

Henry Burrill – GE is currently updating their storm water plan.

#### III. Penobscot County EMA Updates Bradley Nuding

Penobscot County EMA has received a new Commodity Flow Study that can be used to determine which chemicals are being shipped through the communities. SERC is reevaluation the fee structure for tier II reporters. More information will be coming. The Orono RRT is looking to increase their funding. An updated coverage map for the RRTs has been distributed and shows the large coverage area of the team.

- Participation of community water systems and LEPCs / SERC
- Education of LEPCs / SERC / Response agencies to notify CWS if there is a spill
- Collaborative exercising, planning, and response.
- The role of MRWA is fostering these relationships
